W. Walton – Viola Concerto, 1st movement

P. Hindemith – Viola Concerto "Der Schwanendreher", 1st movement

and orchestral parts:

G. Bacewicz – Concerto for String Orchestra: numbers 17 – 12
P. Tchaikovsky – Serenade op.48. 1st movement, D to F and 2nd movement, Waltz D to F
J. Suk – Serenade, Allegro giocoso, from the beginning to G
E. Grieg – Aus Holberg Zeit Suite: Rigaudon – solo from the beginning to U

Important: the candidate may be asked to play orchestral parts at every stage of the audition. Selected fragments are marked in the sheet music available in pdf format.

The organizer provides an accompanist only on the day of the audition.
